ELIGIBILITY

U.S. and foreign players: USTA age rules apply. 14 & under – Born in 2004 or 2005 12 & under – Born in 2006, or 2007 Players in the U12 boys and U12 girls must be 11 or 12 years by December 1, 2018 to play in the U12 division.

ENTRY DEADLINE—OCTOBER 11, 2018

Both entry forms and fees must be received by October 11th. No late entries will be accepted. All withdrawals must be submitted in writing.

Entry Fee: The entry fee is \$130 (U.S. dollars drawn on U.S. banks) and includes a T-Shirt. No phone or fax entries will be accepted.

Acceptance will be at the discretion of the Junior Orange Bowl Tennis Committee. **All foreign players must be endorsed by their respective federations.** Each federation must provide an order of merit listing of all players entering in ranking order and send the list by email to the tournament director. 16 spaces in the main draw will be reserved for qualifying players.

RULES AND REGULATIONS

- Two matches per day may be scheduled. Night play and a third match in one day may become necessary. Play will be 2 out of 3 sets. The Twelve Point Tiebreaker will be used in all sets. Scoring and sites may be changed due to weather conditions.
- The U.S.T.A. Point Penalty System will be enforced. Five-minute warm-up, including practice serves will be allowed. A ten-minute break is allowed between second and third set, and a new can of balls will be used for the third set. Default time is 15 minutes.
- Singles only, there are no doubles in this tournament.
- No on-site alternates


